  4. Pursuant to Rule 20 (4) (v) of the Companies (Management and Administration) Rules, 2014 as amended from time to time and the remote e-voting opened on Friday, 20.02.2026, at 09.00 am (IST) and closed on Saturday, 21.03.2026 at 05.00 pm (IST).
